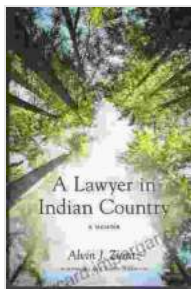


# Lawyer in Indian Country: A Memoir of Justice and Reckoning

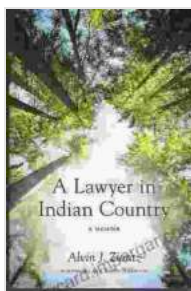
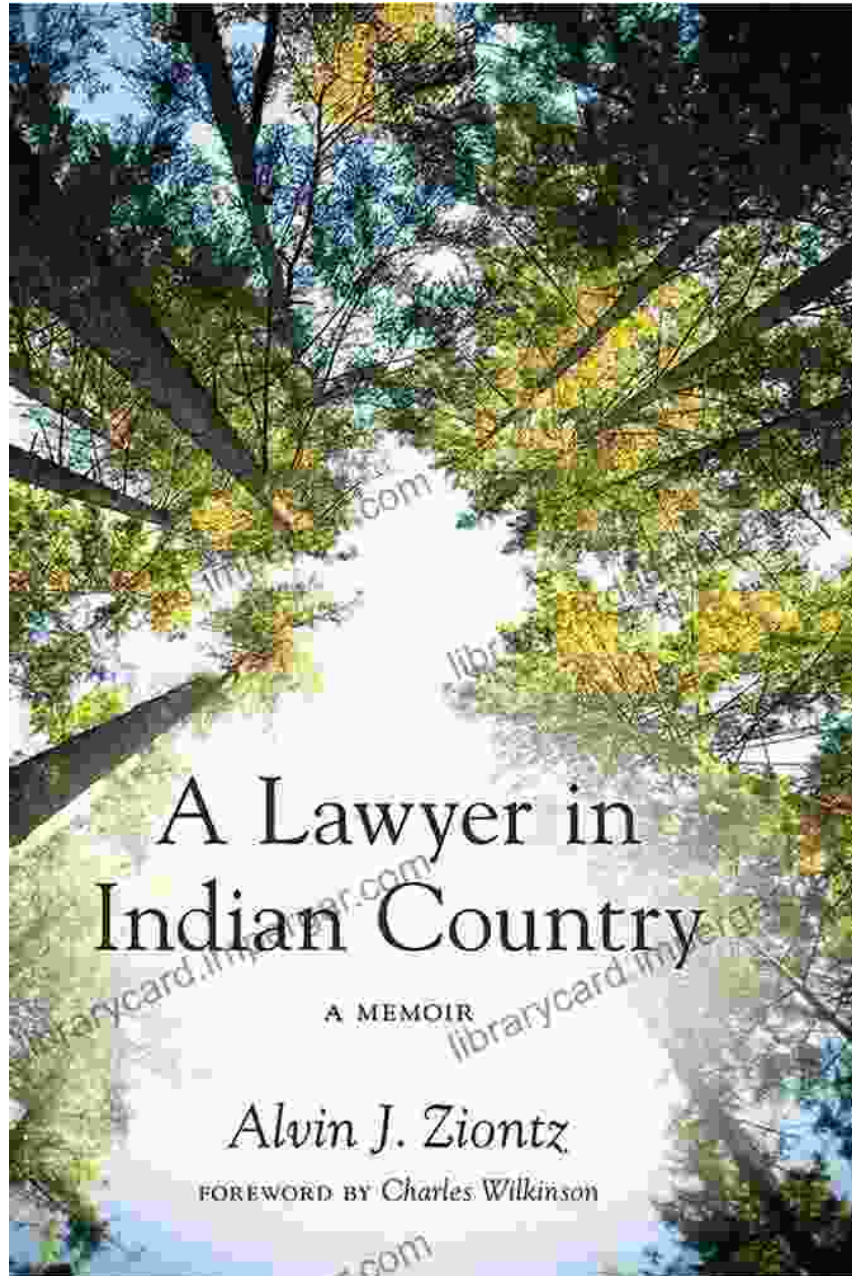

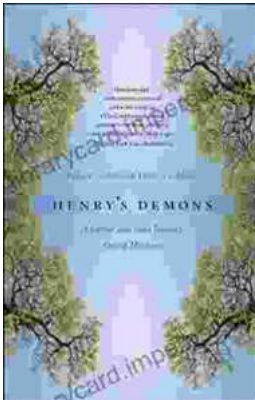
